It comes to the attention of the Court that the road in District No. 35 known as the Old Cy Roberts Road is rendered useless, dangerous and burdensome to maintain. The said road is rendered useless by the construction of a new road on an easy grade through the Cy Roberts Canyon to connect all those people living on top of the Cy Robert's Hill, said road is so constructed and laid out that there will be no further call or necessity of maintaining the old Cy Roberts Road.

The Description of the Road is as follows;

Beginning at stone at the S.W. Corner of that certain 100 acre tract now owned by Cy Roberts and being in the center of the Old County Road and beginning of change for New Road and on the line between the A.H. Roberts and Henry Roberts Donation Land Claims about 33.50 chains N. 48 deg. E. from the S. W. Corner of Henry Roberts Claim in Section 2. Tp. 3. S. R. 4. W. of the Will. Mer. Oregon.

IT IS FURTHER AGREED by and between Mr. Cy Roberts and the County Court at the time of granting the Right of Way for the new road that the old road would be vacated as soon as the new road was made passable, and in pursuance to the foregoing facts the County Court does hereby instruct the County Surveyor to post three copies of the foregoing resolution in three public places on or near the old road and one copy on the bulletin board at the Court House, And the County Surveyor is further directed and ordered to examine said road and make a report in writing on the same.

A hearing will be had on the said resolution on the 14th day of April, 1924.

Thereupon the Court adjourned to meet Wednesday, the 12th day of March, 1924.
